PROPOSED AMENDMENTS TO THE POLICY

1.1	INTRODUCTION In recent years, various stakeholders and the general public have made certain recommendations which have made it necessary to amend the policy that was published in 2015. The school calendar for a particular year structures the total number of days allocated for teaching and learning in that year and stipulates the dates of commencement and termination of the school terms and the length of school holidays. Usually, the calendar is not exactly the same two years running. Although there are various general principles that guide the process of determining school calendars, a set of specifications is also needed to ensure consistency. This policy serves as that set of specifications. Educators must report for work two days before the learners – that is, on the Monday before the learners start – to finalise preparations for the new academic year.
