INVITATION TO NOMINATE MEMBERS TO SERVE ON THE NATIONAL EDUCATION AND TRAINING COUNCIL

I, Ms Siviwe Gwarube, Minister of Basic Education, hereby invite, in terms of Regulation 6(1) of the Regulations for the Establishment of the National Education and Training Council (*Government Gazette* 32629, Government Notice R974, 9 October 2009), nominations of members to serve on the National Education and Training Council (NETC) from:

- (a) national organisations or bodies with a direct and continuing interest in education and training;
- (b) national consultative or advisory bodies on education and training established by law; and
- (c) the public.

The NETC is as an advisory body to the Minister of Basic Education in relation to policy matters pertaining to school education, including any matter contemplated in section 3 of the National Education Policy Act, 1996 (Act No. 27 of 1996, as amended) and any matter identified by the Minister of Basic Education.

Appointment of members of the NETC must be undertaken by the Minister of Basic Education in such a manner as to ensure, in so far as it practically possible, that the functions of the NETC are performed according to the highest professional standards and the membership of the NETC, taken as a whole, has the following characteristics:

- broad representation of the education and training system;
- thorough knowledge and understanding of education and training;
- appreciation of the role of the education and training system in reconstruction and development;
- known and attested commitment to the interests of education and training.
- representation on such relevant grounds as race, gender and disability.

The NETC must consist of up to fifteen members, including a chairperson and not more than fourteen members, and must hold office for a period of three years.

The following information and documentation must be provided in respect of the person or organisation nominating and the person being nominated:

- 1) Full name of the person or organisation nominating the nominee;
- 2) Physical and postal address of the person or organisation nominating the nominee;
- 3) Telephone number of the person or organisation nominating the nominee;
- 4) Email address of the person or organisation nominating the nominee;
- 5) Full name of the nominee;
- 6) Curriculum vitae of the nominee;
- 7) Physical and postal address of the nominee;
- 8) Telephone number of the nominee;

- 9) Email address of the nominee; and
- 10) A letter from the person or organisation nominating the nominee or from the nominee, which letter must (i) confirm the nomination; (ii) provide a motivation for the nomination (with reference to mandate and composition of the NETC); (iii) confirm the availability of the nominee to serve on the NETC, if appointed; and (iv) be signed by the person or organisation nominating the nominee (if applicable) and by the nominee.

Nominees shall be subjected to clearance and disclosure of business interests.
