# 1. Intshayelelo

UmThetho woFikelelo kuLwazi, 2000 (umThetho wesi-2 ka-2000) (PAIA), othathwe kwicandelo lama-32 loMgaqo-siseko weRiphabliki yoMzantsi Afrika, 1996 (uMgaqo-siseko) wenza ukuba kusebenze ilungelo lomgaqo-siseko lofikelelo kulo naluphi na ulwazi wazi olugcinwe ngurhulumente okanye naluphi ulwazi olugcinwe nguye nawuphi omnye umntu, ngaphandle kokuba ulwazi olunjalo lufunelwa ukusebenzisa okanye ukukhusela naliphi na ilungelo.

ICandelo lama-32(1)(a) loMgaqo-siseko ligxininisa ilungelo lomntu wonke lokufumana ufikelo kulo naluphi ulwazi olugcinwe ngurhulumente.

Injongo ye-PAIA inemiba emibini:

1. Ukufaka inkcubeko yokungafihli kunye nokuthatha uxanduva kumaqumrhu karhulumente kunye nawabuvala ngokwenza kusebenze ilungelo lofikelelo kulwazi; kunye
2. nokukhuthaza ngamandla indawo yoluntu leyo abantu baseMzantsi Afrika nabofikelelo olusebenzayo kulwazi ukubenza ukuba basebenzise kwaye bakhusele onke amalungelo abo ngokuphelele ngokungaphaya.

Phambi kowama-27 Epreli 1994, inkqubo karhulumente elizweni yakhokelela kwinkcubeko yokufihla, ukungasabeli kumaqumrhu karhulumente kunye nawabucala, oko kaninzi kwakhokelela ekusetyenzisweni kakubi kwamagunya kunye nokugxojwa kwamalungelo oluntu.

I-PAIA yaqala ukusebenza ngowe-9 Matshi 2001.

## 2. Umbono, injongo neenqobo ezisemgangathweni zeSebe leMfundo esiSiseko (Department of Basic Education) (DBE)

### Umbono

Umbono wethu nguMzantsi Afrika lowo bonke abantu bawo baza kuba nofikelelo ekufundeni ixesha elide, amathuba emfundo noqeqesho lawo, ngenye indlela, aza kuba negalelo ekuphuculeni umgangatho wobomi kunye nokwakha uMzantsi Afrika onoxolo, onempumelelo nonedemokrasi.

### Injongo

Ukusebenza kunye namaphondo, injongo yethu kukubonelela ngemfundo efanelekileyo nesemgangathweni ephambili kwinkulungwane yama-21.

### Iinqobo ezisemgangathweni

Ukubeka umdla wabantwana bethu kuqala, iSebe libambebele kwiinqobo ezisemgangathweni ezilandelayo:

- **Abantu:** Ukugcina uMgaqo-siseko, ukuthatha uxanduva kurhulumente kunye nasebantwini baseMzantsi Afrika.

- **Ukugqwesa:** Ukugcina imigangatho ephezulu yokusebenza kunye nobungcali ngokujolisa ekugqweseneni kuyo yonke into esiyenzayo, kuquka ukuba nobulungisa, iinqobo ezisemgangathwnedi nokuthembeka kiuyo yonke into esiyenzayo.
- **Ukusebenza njengeqela:** Ukusebenzisana omnye nomnye kunye namahlakani ethu kwimfundo ngendlela engafihliyo nexhasayo ukuphumeza iinjongo ekwabelwana ngazo.
- **Ukufunda:** Ukuseka imibutho yokufunda leyo amalungu abasebenzi afuna kwaye abelane ngolwazi, ngexa ezibophelele ekukhuleni kobuqu.
- **Ukuvelisa okutsha:** Ukuzamela ukulungisa iimfuno zoqeqesho zenkonzo ekumgangatho ophezulu kunye nokufuna iindlela zokuphumeza iinjongo zethu.

### 3. Imisebenzi kunye nolwakheko lwe-DBE

#### 3.1. Imisebenzi ye-DBE

Imisebenzi engundoqo ye-DBE njengeziko likarhulumente kukuphuhlisa kunye nokugcina inkqubo yezemfundo. I-DBE ke ngoko inoxanduva lokuphuhlisa umgaqo-nkqubo kunye nenkqubo-sikhokelo yomthetho ekubeni yeyiphi na inkqubo yezemfundo engcono, ukuqinisekisa ukuba –

- (1) onke amanqanaba enkqubo abambeleva kule migaqo-nkqubo kunye nemithetho;
- (2) iindlela ziyasebenza zokubeka iliso kunye nokunyusa umgangatho wenkqubo; kunye
- (3) nokuba inkqubo ihlala inolwazi ngophuhliso kwiinkqubo zemfundo.

#### 3.2. Imisetyenzana eyenza imisebenzi

##### (1) UKUQWALASELA KWAKHONA KOPHANDO NOMGAQO-NKQUBO

I-DBE iqalisa, iyalele, ihole, iqwalasele kwakhona kwaye iphande yonke imiba yenkqubo yemfundo ukunceda ekuphuhliseni nasekugcineni inkqubo.

##### (2) UCWANGCISO NOPHUHLISO LOMGAQO-NKQUBO

I-DBE iqalisa kwaye ilawule iinkqubo ezikhokelela ekuphuhliseni komgaqo-nkqubo kunye nomthetho wokunceda uMphathiswa ekumiseleni umgaqo-nkqubo, izithethe nemigangatho njengoko zifunwa nguMgaqo-siseko.

##### (3) INKXASO

I-DBE inika inkxaso kumaphondo ekuphumezeni kwawo umgaqo-nkqubo wesizwe, izithethe nemigangatho.

##### (4) UKUBEKA ILISO NOKUHLOLA

I-DBE ibeka iliso kwaye inike ingxelo ngokuphunyezwa komgaqo-nkqubo, izithethe nemigangatho ukuhlola iimpembelelo ngomgangatho wenkqubo yemfundo, kunye nokuchonga izikhewu zomgaqo-nkqubo.

##### (5) AMANGUNYA OMTHEHO KUNYE NANGAMANYE

Iqela lemigaqo-nkqubo liphunyeziwe, kwaye nomthetho wawiswa, ukudala inkqubo-sikhokelo yotshintsho kwezemfundo. Imigaqo-nkqubo engundoqo elandelayo kunye nomthetho zilawula imfundo (ngaphandle koMgaqo-siseko, zonke izinto ezidweliswe ngezantsi zivela kwi-DBE):

- (a) UMgaqo-siseko ufuna ukuba imfundo itshintshwe kwaye yenziwe ibe yeyedemokrasi ngokungqinelana neenqobo ezisemgangathweni zesidima somntu, ulingano, amalungelo oluntu nenkululeko, ukungacaluli kunye nokungacaluli ngokwesini. Iqinisekisa ufikelelo kwimfundo esisiseko kubo bonke abantu: " wonke umntu unelungelo lemfundo esisiseko, kuquka imfundo esisiseko yabadala".
- (b) Inkqubo-sikhokelo yomgaqo-nkqubo engundoqo yeSebe leMfundo esiSiseko ixelwe kwiPhepha leNgcaciso-nkqubo leSebe lokuqala, iMfundo noQeqesho kuMzantsi Afrika oneDemokrasi: AmaNyathelo okuQala okuPhuhlisa iNkqubo eNtsha (Februwari 1995). Inkqubo-sikhokelo yomgaqo-nkqubo wemfundo ka-1994 ye-ANC yenza isiseko solu xwebhu. Ikhabinethi yawuvuma emva kokudibana okunzulu, uthetha-thethwano kunye nokujongwa kwakhona. Usebenze njengongqinisiso olungundoqo kuphuhliso lomgaqo-siseko nolomthetho.
- (c) UmThetho woMgaqo-nkqubo weMfundo weSizwe, 1996 (umThetho wama-27 ka-1996) (National Education Policy Act) (NEPA), wayilelwa ukuba ufakwe kwimigaqo-nkqubo yomthetho, ngokunjalo namaxanduva omthetho kunye nawokubeka iliso oMphathiswa weMfundo esiSiseko, kunye nokwenza bube sesikweni ubudlelwane phakathi kweziphathamandla zesizwe nezamaphondo. Wabeka isiseko sokusekwa kweBhunga labaPhathiswa bezeMfundo (Council of Education Ministers) (CEM) neKomiti yeeNtloko zeKomiti zamaSebe eMfundo (Heads of Education Departments Committee) (HEDCOM) njengamaqumrhu aphakathi kurhulumente ajolise ekuhlanganyeleni ekuphuhliseni inkqubo yezemfundo entsha. Xa kunjalo, ubonelela ngokusekwa kwemigawo-nkqubo yesizwe jikelele kunye nangokusa phambili imfundo noqeqesho ngokuphathelene, phakathi kwezinye izinto, nekharityhulam, uhlolo nolwimi.
- (d) UmThetho weziKolo waseMzantsi Afrika, 1996 (umThetho wama-84 ka-1996) (South African Schools Act) (SASA), ukhuthaza ufikelelo, ubulunga kunye nolawulo lwedemokrasi kwinkqubo yokufunda. Uqinisekisa ukuba bonke abafundi banofikelelo kwimfundo esemgangathweni kungekho kucalulwa, kwaye wenza ukuba kunyanzeleke ukufunda kubantwana ababudala buyiminyaka esixhenxe ukuya kweli-15. Ubonelela izikolo ezizimeleyo kunye nezikolo zikarhulumente. Wenza ulungiselelo lwamaqumrhu alawula izikolo (school governing bodies) (SGBs) anedemokrasi, kwaye ii-SGBs ngoku zikhona kuzo zonke izikolo zikarhulumente kwilizwe ngokubanzi. Izithethe zokuxhasa izikolo, ezichazwe kwi-SASA, zibeka phambili ukulungisa kwaye zijolise ebuhlwempini ngokuphathelene nokwabniwa kwemali yenkqubo yezikolo zikarhulumente.
- (e) Isipektram xa sisonke somthetho, kuquka umThetho weNgqesho yooTitshala, 1998 (umThetho wama- 76 ka-1998), ulawula amaxanduva omsebenzi wobungcali, ukulunga neenqobo ezisemgangathweni kootitshala kunye neemfuneko zokufaneleka ezisebenzayo koototshala. Ukufundisa obekohluliwe ngokwembali ngoku kulawulwa ngumThetho wePalamente omnye kunye nalibhunga elinye lomsebenzi wobungcali, iBhunga looTitshala laseMzantsi Afrika ( South African Council for Educators) (SACE).

- (f) I-CAPS (i-Curriculum Assessment Policy Statements), yikharithulam enye, ebanzi, enye nechaneke ngqo emele ingxelo yomgaqo-nkqubo yokufunda nokufundisa kwizikolo zaseMzantsi Afrika. Yikharithulam exhasa iinkqubo ezahlukeneyo ezilandelwayo kwibanga ngalinye, ukusukela kwiBanga R ukuya kwiBanga le-12, oko kukuthi, ngendlela yayo, ixhasa imithetho-siseko elandelayo:
- (i) Utshintsho ekuhlaleni;
  - (ii) ukucinga ngokubonakalayo nangokuhlalutyayo
  - (iii) ulwazi oluphezulu kunye nezakhono eziphezulu;
  - (iv) inkqubela phambili;
  - (v) ukuhlonipha amalungelo oluntu kunye neenkqubo zolwazi lwemveli;
  - (vi) ukuthembeka;
  - (vii) umgangatho nokusebenza; kunye
  - (viii) nolungiselelo lwemfundo olo, ngokomgangatho, ububanzi nobunzulu, lunokuthelekiswa kwimfundo enikwa kwamanye amazwe.

### 3.3. Ulwakheko lwe-DBE

I-DBE yohlulwe ngoko kubhekiselwa kuko "njengamaCandelo". Icandelo ngalinye, longanyelwe ngusekela mlawuli-jikelele, lohlulwe ngokungaphaya ngokwamacandelwana aziintloko. Amacandelana aziintloko ohlulwe kananjalo aba liqela lamacandelwana, lawo, ngenye indlela, ohlulwe aba ngamacandelwana anganeno. I-DBE inecandelo elinye kananjalo ekuthiwa ziyunithi, hayi icandelo.

ISebe linamacandelo asibhozo, njengoko kukhonjisiwe ngezantsi:

#### 3.3.1. ICandelo A: IziMali noLawulo

*Linika inkxaso yolawulo kwi-DBE.*

##### **IMISEBENZI:**

- (a) Ukunika iinkonzo zokufunwa kwabasebenzi abatsha nemicimbi yabasebenzi.
- (b) Ukunika inkxaso ye-HR kumaphondo.
- (c) Ukunika iinkonzo ezahlukeneyo kwiofisi kaMphathiswa.
- (d) Ukunika iinkonzo zomthetho.
- (e) Ukujonga uqeqesho lwabasebenzi kunye nobudlelwane babasebenzi.
- (f) Ukujongana nemicimbi yobudlelwane kwezemisebenzi.
- (g) Ukunika inkxaso yobuChwepheshe boLwazi ngeKhompyutha nge-GITO.
- (h) Ukunika iinkonzo zequmrhu.
- (i) Ukunika iinkonzo zezimali ngeofisi yeGosa eliyiNtloko leziMali.

#### 3.3.2. ICandelo C: UMgaqo-nkqubo weKharithulam, iNkxaso nokuBeka iLiso

*Liphuhlisa umgaqo-nkqubo nenkxaso yekharithulam nowohlolo, kwaye libeka iliso kwaye lihlole ukuphunyezwa kwekharithulam. Lixhasa ngu-Umalusi.*

**IMISEBENZI:**

- (a) Liphuhlisa umgaqo-nkqubo wekharithulam kumaBanga R ukuya kwele-12, kuquka neMfundo yeeMfuno eziKhathekileyo.
- (b) Liphumeza umgaqo-nkqubo kunye nokugcina ikharithulam kumaBanga R ukuya kwele-12, kuquka neMfundo yeeMfuno eziKhathekileyo, ukuphucula ukufunda nokufundisa.
- (c) Ukunika inkxaso yomgaqo-nkqubo kwiintlobo ezahlukeneyo zeeprojekthi, kuquka iMibutho yokuFunda, iDinaledi, ii-ICT, NSLA ne-QIDS UP.
- (d) Ukuqhuba iProjekthi yoLwazi lokuFunda iKha Ri Gude.

**3.3.3. IYunithi eyoNgamele uCwangciso noFezekiso**

*Ukunceda iOfisi yoMphathiswa ne-DBE ukuba ihlangabezane neenjongo zesticwangciso.*

**IMISEBENZI:**

- (a) Ukunceda iOfisi yoMphathiswa ne-DBE ukuba ihlangabezane neenjongo zesticwangciso ngokuchonga kunye noulungisa iinkalo ezikhethiweyo zomngeni.
- (b) Ukukhokela nokulawula iqela leengcali elikwinqanaba eliphezulu ukuba lilungise imingeni ekhethiweyo ukuze lizise unikezo lwemfundo olunempumelelo
- (c) Ukomoleza uthabatho nxaxheba lwabo kusetyenziswana nabo ekuphuculweni komgangatho weziphumo zemfundo oko kusenziwa ngokusekwa lwamaziko asebenzayo e-QLTC kuwo onke amanqanaba enkqubo.

**3.3.4. ICandelo P: UCwangciso, uLwazi noHlolo**

*Likhuthaza unikezo lweenkonzo ezisemgangathweni nezinempumelelo kwinkqubo yemfundo esisiseko oko kusenziwa nokuphunyezwa kocwangciso nohlolo. Lixhaswa yi-NEEDU.*

**IMISEBENZI:**

- (a) Kukuqhuba ukubeka iliso nohlolo oko kusenziwa ngophando, amahlolo enkqubo, amahlolo esizwe, amahlolo amazwe ngamazwe kunye neemviwo zesizwe.
- (b) Ukulawula izimali zecandelo lemfundo esisiseko kunye nocwangciso lwemithombo ngqo.
- (c) Ukulawula iinkqubo zolawulo lolwazi zecandelo lemfundo esisiseko.

**3.3.5. ICandelo S: UkuHlanganisa ngokweNtallo neNkonzo zeNkxaso**

*Lihlanganisa onke amacandelo oluntu ekuxhaseni imfundo esisiseko kwaye liququzelela ulungiselelo lweenkqubo zokunika ulwazi kuphuhliso olupheleleyo kunye nempilontle yabo bonke abafundi.*



### **IMISEBENZI:**

- (a) Ukukhuthaza intsebenziswano karhulumente neyabucala, ngokunjalo nentsebenziswano nee-NGO, ukuqinisekisa ukuba uluntu ludlala indima ekuphumezeni imfundo esemgangathweni kuzo zonke izikolo zikarhulumente.
- (b) Ukukhuthaza ukuba kuziwe ezikolweni kunye nempumelelo phakathi kwabafundi abasesichengeni ngokubanika izidlo ezinesondlo kusuku ngalunye lwesikolo.
- (c) Ukuseka iimo ezingqongileyo ezikhuselekileyo zokufundisa nokufunda kuzo zonke izikolo zikarhulumente.
- (d) Ukuba negalelo ekugcinweni kwabafundi ngokunyusa inani lezikolo ezithabatha inxaxheba kwimisetiyenzana yezemidlalo yezikolo eququzelelwe kakuhle kunye neenkqubo zemfundo zomculo.
- (e) Ukuququzelela ukuchongwa kunye nokunyangwa kwangoko kwezithintelo zempilo ekufundeni.
- (f) Ukuphucula ukusebenza nokugcinwa kwabafundi ngokuxhasa amaqumrhu alawula isikolo kunye neenkqubo zokuqeqesha ootitshala ukukhuthaza amalungelo oluntu, iyantlukwano kunye nokunamathelana kwezintlalo, ngaloo ndlela beququzelela ukugqwesa kwezemfundo kunye nokuncitshiswa kwabantwana abayeka isikolo.
- (g) Ukuphucula ulingano ngokwesini ezikolweni.
- (h) Ukonyusa ulwazi ngempilo yezesondo kunye neyokuzala, zakhono kunye nokwenziwa kwezigqibo phakathi kwabafundi, ootitshala kunye nabasebenzi abaxhasayo besikolo.
- (i) Ukukhuthaza impilo ntle enxulumene neempembelelo zemiba yentlalo ekuziphatheni kunye nokuququzelela ufikelelo kwiinkonzo ezinxulumene neempembelelo zemiba yentlalo ezikolweni.
- (j) Ukuhlenganisa uluntu kunye nabo bonke abasebenza noluntu ukuxhasa ukufunyanwa kwemfundo esemgangathweni.

#### **3.3.6. ICandelo R: ISicwangciso, uPhando noNxibelelwano**

*Lixhasa ulungelelwaniso kunye nokuphunyezwa kwesebe, iinkqubo zokusebenza zecandelo ngokubanzi kunye nezeqela.*

### **IMISEBENZI:**

- (a) Ukongamela ukuphunyezwa kweenkqubo kunye namaphulo esebe.
- (b) Ukulawula ulungelelwaniso namaQela oo-DG, iPalamante neKhabhinethi.
- (c) Ukuqhuba uyilo lwezicwangciso kunye nokunika ingxelo okunxulumene namanyathelo enkqubo kaRhulumente.
- (d) Ukulungelelanisa iinkonzo zoMphathiswa, iPalamante, CEM, HEDCOM, uLawulo oluPhezulu kunye noLawulo ngokuBanzi.
- (e) Ukulawula, ukubeka iliso kunye nokunika ingxelo ngabanikeli kunye nokunikwa kwenkxaso.

- (f) Ukubeka iliso nokunika ingxelo ngokusebenza xa kukonke kwenkqubo yezemfundo oko kusenziwa ngemisetyenzana yohlalutyo, uphando, ukubeka iliso nokuhlola.

### **3.3.7. ICandelo T: OoTitshala, iMicimbi yabaSebenzi yezeMfundo kunye noPhuhliso lweZiko**

*Likhuthaza ukufundisa okusemgangathweni kunye nokusebenza kweziko oko kusenziwa ngabasebenzi abasebenza ngempumelelo, uphuhliso kunye nokusetyenziswa kwemicimbi enxulumene nabasebenzi ngokuhlanganyelana ne-ETDP SETA, i-ELRC ne-SACE.*

#### **IMISEBENZI:**

- (a) Ukujongana noyilo lwemicimbi enxulumene nabasebenzi, kuquka uLawulo lwe-HRMIS ne-HR.

- (1) Ugunyaziwe wezibheno wangaphakathi (ugunyaziwe obandakanyekayo) ngeenjongo zalo mThetho nguMphathiswa. Umceli unokufaka isibheno esebenzisa iFom B. Emva kokugqiba ulungiso lwesibheno sangaphakathi, isicelo sinokungeniswa enkundleni (amacandelo elama-78 ukuya kuma-82).
- (2) Umsebenzi karhulumente unokufaka isikhalazo ukuba siphandwe yiKomishoni yeNkonzo kaRhulumente ngokuphathelene nesenzo esisemthethweni okanye ukungenziwa kwaso (icandelo lama-35 lomThetho weNkonzo kaRhulumente, 1994. [INomboilo yesiBhengezo 103 aika-1994]).
- (3) Umntu unokusebenzisa uncedo lwezemisebenzi ngokuphathelene nezenzo ezisemthethweni okanye ukungenziwa okumayela nemisebenzi - eyile imbambano yamalungelo (umThetho weNkonzo kaRhulumente, 1994, kunye nomThetho wezabaSebenzi, 1995 (umThetho wama-66 ka-1995)).
- (4) Umntu unokufaka isikhalazo kumhloli wezemisebenzi ngokuphathelene nolwaphulo olusolwayo lomThetho weeMeko eziSisiseko zeNgqesho, 1997 (umThetho wama-75 ka-1997 icandelo lama-78(1)(a), okanye umThetho wobuLungisa kwiNgqesho, 1998 (umThetho wama-55 ka-1998 - icandelo lama-34(e)).
- (5) Umntu unokufaka isikhalazo kuMkhuseli woluNtu ngokuphathelene nesenzo esikrokrelwayo esingekho mthethweni okanye esingafanelekanga okanye ukungenziwa (uMgaqo-siseko kunye nomThetho woMkhuselo woluNtu, 1994 (umThetho wama-23 ka-1994)).
- (6) Nawuphi na umntu ofaka isikhalazo kwi-SAHRC ngokuphathelene nesenzo esisemthethweni okanye ukungenziwa kwaso ekukrokelwa ukuba sigxobha okanye sisongela naliphi na ilungelo elingundoqo (umThetho wamaLungelo oluNtu, 1994 (umThetho wama-54 ka-1994)).
- (7) Ukuze ukhuselwe kwimpindezelo ngenxa yokuxela ngokuphathelene nokuziphatha okungekho mthethweni okanye okungafanelekanga ngumqeshi okanye ugxaxaxa osebenza naye, umntu obandakanyekayo unokulandela iinkqubo zokuxela ezibekwe kumThetho wokuXela okuKhuselweyo, 2000 (umThetho wama-26 ka-2000).
- (8) Umntu unokusebenza olunye uncedo lomthetho olufana neenkqubo zeziko kuqwalwaselo kwakhona ngumthetho lwamanyathelo olawulo ngokomThetho wokuKhuthazwa koLawulo lobuLungisa, 2000 (umThetho wesi-3 ka-2000).

**8.2.** Olunye uncedo oluxhasayo

- (1) Umntu unokucela izizathu zenyathelo lolawulo ngokomThetho wokuKhuthazwa koLawulo lobuLungisa, 2000 (icandelo lesi-5).
- (2) Nawuphi na umntu unokucela ufikelelo kwiirekhodi zesebe likarhulumente okanye iqumrhu likarhulumente ngokwe-PAIA, 2000 (icandelo le-11).

**8.3.** Umsebenzi wokuxela

- (1) IKhawudi yokuziPhatha yabaSebenzi bakaRhulumente, epapashwe yiKomishoni yeNkonzo kaRhulumente ithi, ukuba, ekwenzeni imisebenzi yakhe esemthethweni, umsebenzii wenkonzo karhulumente udibanano nobuqhetseba, urhwaphilizo, ukuqesha izihlobo, ulawulo olugwenxa okanye nasiphi na isenzo esenza ityala okanye esigwebayo kokusemdleni woluntu, kufuneka awuxele umba onjalo kwiziphathamanda ezifanelekileyo. Umsebenzi osilelayo ukwenza njalo unetyala lokungaziphathi kakuhle.

- (2) Uxanduva lomqeshi nomsebenzi ngamnye lokuxela ukuziphatha okunolwaphulo-mthetho nokungafanelekanga emsebenzini luxhasa kananjalo umThetho wokuXela okuKhuselweyo, 2000 (Isingeniso).

## 9. UkuSebenza ngoLwazi lobuQu

ISahluko sesi-3 somThetho we-POPI sibonelela ngobuncinane bemiQathango ngokuSetyenzwa ngokusemThethweni koLwazi lobuQu liQele elinoXanduva. Le miqathango ngeke yehliswe ngaphandle kokuba okukhutshelwa ngaphandle okuthile kuyasebenza njengoko kuchaziwe kumThetho we-POPI.

Iqela elinoxanduva kufuneka liqinisekise ukuba imiqathango ebekwe kwiSahluko sesi-3 somThetho we-POPI kunye nawo onke amanyathelo awenza kusebenze imiqathango enjalo, iyathotyelwa ngexesha lokumiselwa kwenjongo kunye endlela yokusetyenzwa kunye nokusetyenzwa ngokwako.

I-DBE maxa onke, ekuthobeleni kwayo icandelo lesi-5 lomThetho we-POPI iqinisekisa ukuba uLwazi lobuQu lomNtu weDatha—

- (a) kusetyenzwa ngalo ngokusemthethweni, ngokufanelekileyo nangokungafihliyo;
- (b) kusetyenzwa ngalo kuphela ngeenjongo ezo luqokelelelwe zona;
- (c) ngeke kusetyenzwe ngalo ngeenjongo ezinganeno ngaphandle kokuba oko kusetyenzwa kuthelekiswa nenjongo yokuqala;
- (d) lwanele, lubalulekile kwaye alugqithisanga ngeenjongo ezo luqokelelelwe zona;
- (e) luchanekile kwaye lugcinwa luhlaziywa;
- (f) ngeke lugcinwe ngaphezu koko kuyimfuneko;
- (g) kusetyenzwa ngalo ngokungqinelana nemithetho-siseko yemfezeko neyobumfelo; oko kuquka amanyathelo obuqu nawombutho okuqinisekisa ukuba uLwazi lobuQu, ngazo zombini iintlobo olukhona ngqo kunye nolukwi-eletroniki, luxhomekeke kwinqanaba elifanelekileyo lokhuselo xa lubekwa, lusetyenziswa kwaye kunxityelelwana ngalo kwi-DBE, ukuze lukhuselwe kufikelelo okanye ekufunyanweni ngabantu abangagunyaziswanga kunye nokulahleka ngengozi, ukutshabalala okanye umonakalo;
- (h) kusetyenzwa ngalo ngokungqinelana namalungelo abaNtu eDatha.

### 9.1. INjongo yokuSebenza ngalo

ULwazi lobuQu kunokusetyenzwa ngalo kuphela kwinjongo ethile.

I-DBE isebenzisa uLwazi lobuQu oluphantsi kokhathalelo lwayo ngeendlela ezilandelayo:

- Ulawulo lwabasebenzi;
- Ukugcina iirekhodi zabafundi notitshala;
- Ukugcina iirekhodi zabaniki sitokhwe nababoneleli ngeenkondo;
- Ukugcina iirekhodi zabo kusetyenziswana nabo kwimfundo esisiseko;
- Ukuthobela imithetho yerhafu.

### 9.2. Iindidi zabaNtu beDatha kunye nezolwazi lwabo lobuQu

Idatha enofikelelo lwayo i-DBE ibanzi. Uninzi lwayo 'yidatha yobuqu' ngokomThetho we-POPI. Ingakumbi, inombolo yesazisi enamanani ali-13 yabafundi nabasebenzi, ngokunjalo

namagama abo, isini, kunye nomhla wokuzalwa zinokufunyanwa kule datha. Amasebe emfundo amaphondo afuna ulwazi lobuqu ngeenjongo zokusebenza, kwaye nanjengomthombo woninzi lwedatha ye-DBE idatha yamasebe amaphondo, ulwazi lobuqu luqukiwe.

NgokomThetho woMgaqo-nkqubo weMfundo weSizwe (National Education Policy Act) (NEPA), ukusetyenziswa kwedatha yi-DBE kunyinelwe ekubekeni iliso kunye nokuhlola inkqubela ukuze kuthotyelwe uMgaqo-siseko kunye nomgaqo-nkqubo wesizwe wemfundo. Idatha inokuqokelelwa kwi-EMIS okanye ngezinye iindlela ezifanelekileyo, ngentsebenziswano namasebe emfundo amaphondo. Ukusetyenziswa kweenombolo zeeselula zootitshala kufuneka kunyinwe.

Idatha yobuqu enayo i-DBE iyafunwa, okubalulekileyo, ngeenjongo zohlalutyo kunye nokuzalisekisa izibophelelo zokubeka iliso ze-NEPA. Ingakumbi, ulwazi lobuqu lufunwa xa imithombo eyohlukeneyo yedatha kufuneka idityaniswe. Umzekelo, ukuba ngaba kufuneka kuqhutywe uhlalutyo lokuba baqhube kakuhle kanjani na abo bebebhala uviwo lweBanga le-12 kumaBanga angezantsi kwawebanga le-12, idatha yeemviwo zeBanga le-12 kufuneka idityaniswe kwiiseti zeedatha ezahlukeneyo ezifaka amabanga asezantsi.

Kuhlala kuyimfuneko ukusebenzisa izinto ezininzi ezingafaniyo ekudibaniseni imithombo yedatha kuba okunye okungafaniyo ngokwako kuyakubonisa ukunyina. Njengokuba, inombolo yesazisi enamanani ali-13 idibanisa abafundi abaninzi kuzo zonke iimviwo zeBanga le-12 kunye neeseti zedatha zaphambi kweBanga le-12, kodwa hayi zonke, njengoko ezithile zeenombolo zezazisi zingekhoyo. Kule meko, ukusetyenziswa kwamagama kunye nemihla yokuzalwa zinokusetyenziswa ukuvala isikhewu, kodwa kananjalo ukuqinisekisa ukuchaneka kwenombolo yesazisi yesizwe. Okubalulekileyo, umsebenzi wokubeka iliso ekubhekiselwe kuwo apha awukaze ubandakanye ukuxelwa kolwazi lobuqu kwiingxelo ze-DBE ezikhutshwa njengenxenye yenkqubo. Iingxelo ziya kubonisa kuphela iinkcukacha manani kwinqanaba lokupheleleyo okunxulumene, umzekelo, amazinga okuyeka isikolo.

### **9.3. Iindidi zabaFumani ekuSebenzeni ngoLwazi lobuQu**

ICandelo lama-72 lomThetho we-POPI libonelela ngokuba uLwazi lobuQu lunokudluliswa kuphela luphume kwiRiphabliki yoMzantsi Afrika ukuba—

- (a) ilizwe elilufumayo linokunika idatha enjalo ukhuselo “lwenqanaba elaneleyo”. Oku kuthetha ukuba imithetho yalo yobucala bedatha kufuneka ifane nemiQathango yokuSebenza ngayo esemThethweni njengoko kuchaziwe kwiSahluko sesi-3 somThetho we-POPI; okanye
- (b) UmNtu weDatha uyakuvuma ukudluliselwa koLwazi lwakhe lobuQu; okanye
- (c) ukudluliswa kuyimfuneko ekwenziweni kwezibophelelo zekontraki phakathi komNtu weDatha kunye neQela eliNoxanduva; okanye
- (d) ukudluliswa kuyimfuneko ekwenziweni kwezibophelelo zekontraki phakathi kweQela eliNoxanduva kunye neqela lesithathu, ngokusemdleni womNtu weDatha; okanye
- (e) ukudluliswa kuza kunceda umNtu weDatha, kwaye akunakwenzeka ngokufanelekileyo ukufumana imvume kumNtu weDatha, kwaye ukuba bekunjalo, umNtu weDatha, unokunika imvume enjalo.

Okwangoku, i-DBE ayicebi kuHanjiswa koLwazi lobuQu ngaPhaya kwemida.

### **9.5. AmaNyathelo oKhuselo loLwazi (icandelo le-19 lomThetho we-POPI)**

I-DBE igcine imfezeko kunye nobumfihlo bolwazi lobuqu olukuyo okanye oluphantsi kolawulo lwayo ngokuthatha amanyathelo afanelekileyo, ngobuchwepheshe obufanelekileyo kunye nawombutho ukuthintela ilahleko, okanye umonakalo, okanye ukutshatyalaliswa okungagunyaziswanga, ufikelo olungekho mthethweni, okanye ukusebenza ngolwazi lobuqu.

I-DBE ibeke imithetho yokhuselo yokugada ulwazi lobuqu ekubeni kufikelelwe kulo ngokungekho mthethweni. ISebe licinga ngokunyusa amaNyathelo oKhuselo loLwazi njengokulandelayo:

- (a) Ngokuqinisekisa ukuhlelwa okuchanekileyo kolwazi olurekhodiweyo kuba idatha yabasebenzi iza kuhlelwa 'njengolwazi lobuqu' okanye 'ulwazi lobuqu olukhethekileyo';
- (b) ukuqinisekisa ukuba imithetho yokhuselo iyanyuswa ukugada kufikelelo olungagunyaziswanga kulwazi ngokuphumeza amanyathelo okhuselo ekhompuyutha kunye nothungelwano njengee-password, ukuphumeza ii-firewalls, ukufaka ukhuselo lwe-antivirus, ukuqinisekisa ukhuselo lwedatha ngokuguqulela ulwazi kwikhowudi okanye ukususwa kolwazi lobuqu, ukufumana ii-laptops neekhompuyutha ngeepasswords okanye iimpawu zezandla kunye nokufumana i-Virtual Private Network (VPN);
- (c) imithetho eyazisa abasebenzi okanye abanye abantu xa ulwazi lwabo lobuqu luye lwabonwa, okanye xa kuye kwakho ukophulwa kobucala obunxulumene nolwazi lobuqu olubandakanyekayo; kunye
- (d) nokuqinisekisa ukuba imithetho engqongqo yokhuselo iyamkelwa ukunyina ufikelelo ngamaqela esithathu, okusingqongileyo kweofisi, uthungelwano lwekhompuyutha, inkqubo, i-application software, idatha okanye omnye umthombo.

## **9.6. UkuXelwa koLwazi lobuQu**

I-DBE inokuxela ulwazi lobuqu kwamanye amasebe karhulumente, kumaziko karhulumente kunye nakubaboneleli ngeenkono beqela lesithathu le-DBE. I-DBE unokuxela ulwazi lobuqu kananjalo apho kukho umsebenzi okanye ilungelo lokuxela ngokomthetho osebenzayo, umthetho, okanye apho kunokucingwa ukuba kuyimfuneko ukuze kukhuselwe amalungelo e-DBE.

I-DBE ngesiqhelo ibandakanyeka kwimisebenzi leyo idatha ye-DBE idityaniswe kwenye idatha karhulumente ngeenjongo zokuqinisekisa ubulunga bedatha kunye nokubeka iliso. Njengokuba, i-DBE kunye neArhente yoKhuselo lwezeNtlalo yoMzantsi Aftika (South African Social Security Agency) (SASSA) ziyadibana, zisebenzisa iinkalo zolwazi lobuqu ezahlukeneyo, ukumisela ukuba abo bafumana izibonelelo bakubudala bokuya esikolweni na. Ukudibanisa, idibene neSebe leMfundo yamaZiko aPhezulu (Department of Higher Education) (DHET), iirekhodi zabafundi ebebebhalse ngaphambili ezikolweni kwabo bafundi okwangoku bakumaziko emfundo ephakamileyo kubalulekile ekuqondeni ukuhamba phakathi kwala manqanaba mabini emfundo.

I-DBE iyaqonda ukuba umNtu weDatha unelungelo lokumisela ukuba ingaba i-DBE igcine ulwazi lobuqu olunxulumene naye na, yena okanye yona, kuquka nelungelo lokucela ufikelelo kulwazi lobuqu.



## **10.2. Ilungelo lokuba ulwazi lobuqu lulungiswe okanye lucinywe (icandelo lama-24 lomThetho we-POPI)**

UmNtu weDatha unelungelo lokucela, apho kuyimfuneko, ukuba ulwazi lwakhe okanye lwayo lobuqu malulungiswe okanye lucinywe apho i-DBE ingasagunyaziswanga ukuba igcine ulwazi lobuqu.

## **10.3. Ilungelo lokwala ukuba kusetyenzwe ngolwazi lobuqu**

UmNtu weDatha unelungelo, kwimihlaba efanelekileyo, lokwala ukuba kusetyenzwe ngolwazi lwakhe okanye lwayo lobuqu. Kwimeko enjalo, i-DBE iza kunika ingqalelo efanelekileyo kwisicelo kunye neemfuneko zomThetho we-POPI Act.

## **10.4. Ilungelo lokwala ukuba kuthengiswe ngqo**

UmNtu weDatha unelungelo lokwala ukuba kusetyenzwe ngolwazi lwakhe okanye lwayo lobuqu kwiinkqubo zentengiso ngqo ngendlela yonxibelelwano lwe-eletroniki olunganikwanga ngokuzithandela.

## **10.5. Ilungelo lokwaziswa (icandelo le-18 nelama-22 lomThetho we-POPI)**

UmNtu weDatha unelungelo lokwaziswa ukuba ulwazi lwakhe okanye lwayo lobuqu luqokelelwe yi- DBE. UmNtu weDatha unelungelo lokwaziswa kananjalo ngayo nayiphi na imeko apho i-DBE inemihlaba efanelekileyo yokukholwa ukuba olo lwazi lobuqu lomNtu weDatha kufikelelwe kulo okanye lwafunyanwa ngumntu ongagunyaziswanga.

## **10.6. Ilungelo lokukhalaza kuMlawuli woLwazi**

UmNtu weDatha unelungelo lokungenisa isikhalazo kuMlawuli woLwazi ngokuphathelene nokophulwa okusolwayo kwawo nawaphi amalungelo akhuselwe phantsi komThetho we-POPI.
