This circular deals with:


1. The Programme of Assessment appearing on page 61 of the printed Agricultural Sciences Curriculum and Assessment Policy (CAPS) Document.
2. In April 2013, the Department issued Circular S4 of 2013 on **EDITORIAL AND LAYOUT CHANGES MADE TO THE PRINTED CURRICULUM AND ASSESSMENT POLICY STATEMENTS** for Grade 10, 11 and Intermediate Phase.
3. The Circular stated that the editorial errors which may be detected during the CAPS orientation for Senior Phase (Grades 7-9) and Grade 12 subject advisors during the first half of 2013 would be placed on the departmental website.
4. In the process of implementing CAPS in the Senior Phase and Grade 12, other inconsistencies and technical errors were detected in particular for Agricultural Sciences. An annexure has been prepared in this regard for the smooth implementation of the CAPS.
