CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.

5. For the purposes of this Certificate and the accompanying bid, I understand that the word "competitor" shall include any individual or organization, other than the bidder, whether or not affiliated with the bidder, who:
 - (a) has been requested to submit a bid in response to this bid invitation;
 - (b) could potentially submit a bid in response to this bid invitation, based on their qualifications, abilities or experience; and
 - (c) provides the same goods and services as the bidder and/or is in the same line of business as the bidder

6. The bidder has arrived at the accompanying bid independently from, and without consultation, communication, agreement or arrangement with any competitor. However communication between partners in a joint venture or consortium³ will not be construed as collusive bidding.

9. The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.

³ Joint venture or Consortium means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.

10. I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.

1. PURPOSE

Procure services that will provide armed close protection security services for the North-West Province Administrator.

2. PROBLEM STATEMENT

The Department of Basic Education (DBE) has been tasked by the Presidency to provide administrative duties to the North West Department of Education. An Administrator has been appointed to oversee this process.

3. MANDATORY REQUIREMENTS

Bidders must demonstrate their capabilities and qualifications in rendering and offering the required services as listed below.

The DBE requires the following services:

- 3.1 The service provider and the staff must be PSIRA registered and in possession of a Grade B or A PSIRA certificate.

- 3.4 Two armed protectors must be in possession of a valid advance driver's certificate as they will be expected to drive the vehicle.
- 3.5 The DBE will provide the vehicle and determine the type and category.
- 3.6 Dress code of the two private protectors must be strictly professional.
- 3.7 The Covid-19 protocol measures must be in place during the escorting of the Administrator which include the wearing of cloth masks and sanitizing of the rental vehicle before and after a trip is undertaken.

4. SPECIAL CONDITIONS

- 4.1 The armed protectors will be required to travel and sleep over in Mafikeng as and when required.
- 4.2 The DBE will be responsible for the arrangement of the accommodation for the two private protectors.



4.3 The DBE will remunerate the service provider for out of own pocket fuel and tollgate expenses provided that proof of expenses is submitted.

4.4 The services of the two (2) armed protectors will be required from 1 May to 30 June 2021.

5. LOCATION OF SERVICES

The armed protectors will be commuting between Gauteng and the North West province as and when required.

6. PRICE

6.1 The price will be for rendering the services of armed close protection security services for the North West Administrator.

6.2 The pricing schedule for the daily and monthly rate of the armed protectors should be attached. The working hours are from 06:00 until 18:00 daily from Monday to Friday.

6.3 The service of the private protectors must be available during weekends (Saturdays and Sundays) if the need arises.

7.1 The DBE does not assume responsibility for those inherent risks which may cause unfortunate accidents or incidents during the normal inherent working conditions.

7.2 The DBE will not be held responsible for injury, death, damage, loss, delay, cost, expense, or inconvenience arising from incidences associated with the inherent working conditions beyond our control.

7.3 Failure by the preferred bidder to supply the required services may result in the contract being nullified.

8. SERVICE LEVEL AGREEMENT

A detailed service level agreement will be drawn and agreed upon with the preferred service provider.
